Description



By adjusting the ergonomically designed knob, the end user can control the desired fluid output pressure. Our regulator contains no exposed metallic parts. Additionally, our unique diaphragm design assures that the regulators will not "chatter" at the lower end of the pressure range settings, a behavior common to many types of competing pressure regulators.

Wetted flow path is 100% PTFE and PFA and the regulator is 100% metal-free and elastomer-free, making the UPRP Pressure Regulators an ideal choice for Semiconductor applications, or any other application requiring high purity and/or superior chemical resistance.

- Precise regulation of pressures in aggressive or ultrapure chemical or DI water lines
- Protecting sensitive instrumentation from pressure spikes
- Preventing foreign particles from being forced through filtration membranes due to unstable pressures




